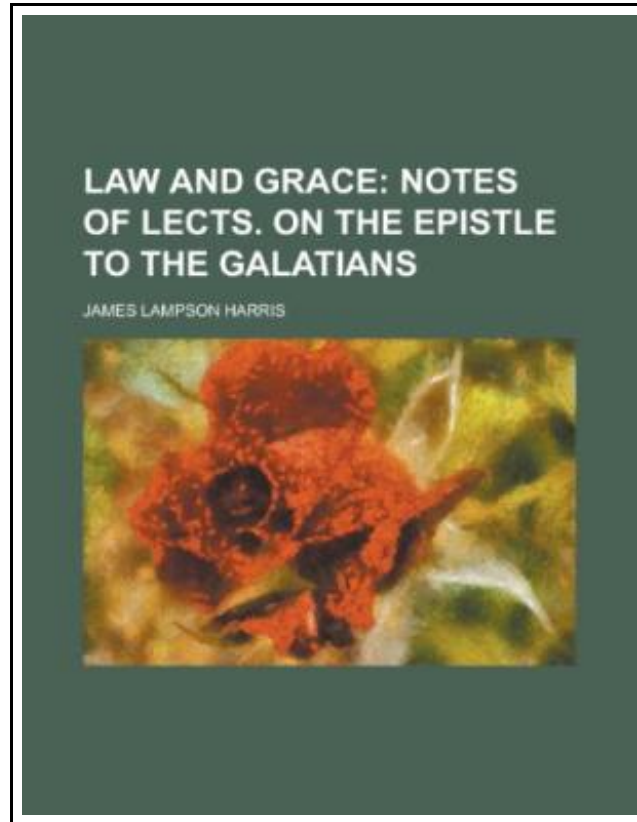

In cases where FRA concludes that an operation is not a railroad for purposes of 49 U. S. C. 20102 (1), local rail service providers, often agencies of state or local governments, may receive capital or operating funds from the Federal Transit Administration (FTA). However, FTA has no statutory authority for safety regulation. Instead, in the Intermodal Surface Transportation Efficiency Act (ISTEA) of 1992, the Congress directed states to designate agencies with safety regulatory responsibility for fixed guideway transportation (including heavy rail, light rail, funiculars, monorails, etc.). State inspectors working with transit properties, however, are not required to be familiar with FRA track safety standards (which may not, in fact, be appropriate for transit systems in all cases). In the case of a transit system located on dedicated tracks adjacent to active freight trackage, FRAs concern is that the operations of a freight railroad in close proximity to a heavy or light rail transit line could present risks for each. For example, a freight train might derail and the derailed cars might encroach on the transit line. Further, a transit vehicle might have to be evacuated, and passengers could find themselves at risk of being hit by a freight train. In addition, roadway workers on the freight railroad might not realize the need to protect against...
